Reasons why project is exempt:

This project will involve the installation of a solar energy system on the roof of an existing building and pursuant to Pub. Res. Code § 21080.35 is exempt from CEQA. The materials will enable the generation and use of solar photovoltaic panels. The system will be installed at a vineyard in San Luis Obispo County. Associated equipment will not occupy more than 500 square feet of ground surface. The project does not involve a federal Clean Water Act permit; waste discharge requirements under Porter-Cologne Water Quality Control Act; individual take permit; streambed alteration permit; or removal of specific required or native trees. For these reasons, this project is statutorily exempt from CEQA under Pub. Res. Code § 21080.35.

This project will involve the installation of an electric vehicle charger in the barn at a vineyard in San Luis Obispo County. The charger will serve electric vehicles. This installation will be a minor alteration to an existing structure with no expansion beyond the existing use of the vineyard operation and will not have significant effect on the environment. The project falls under categorical exemption listed in 14 CCR section 15301.

This project will involve the installation of a battery energy storage unit in a barn at a vineyard in San Luis Obispo County. The battery energy storage unit will serve nighttime operation on the farm. This installation will be a minor alteration to an existing structure with no expansion beyond the existing use of the vineyard operation and will not have significant effect on the environment. The project falls under categorical exemption listed in 14 CCR section 15301.
