PROJECT DESCRIPTION / LOCATION: The project is located within the Castlerock Falls Planning Watershed, approximately 5 miles north of the town of Boulder Creek on the east side of Highway 9, in Santa Cruz County. The project is limited to placement of a temporary Spittler (modified Humboldt) at crossing X1 with addition of a second waterbar to drain water upslope across the road; redirect and straighten the split in an unnamed Class III watercourse above the skid trail between M2 and L2 to drain in a single flow across the road at new map point X9 to stable ground instead of a portion flowing into the inside ditch, and disconnect the inside drainage at the skid trail; and place a temporary Spittler at X3 with an option to use logs or straw.

The California Department of Fish and Wildlife is executing Lake and Streambed Alteration Agreement Number 1600-2018-0394-R3 pursuant to Section 1602 of the Fish and Game Code to the project Applicant: Daniel Falk, RPF, acting on behalf of the owner, Richardson Ranch, LLC.

This is to advise that the California Department of Fish and Wildlife as a Responsible Agency approved the project described above on June 27, 2019, and has made the following determinations regarding the above described project pursuant to section 15096 (i).

1. The project will not have a significant effect on the environment.
