**Project Title**: Thomas Water Diversion Project (Lake or Streambed Alteration Agreement No. 1600-2019-0186-R1)

**Project Location (include county):** The project to be completed is located within the Unnamed Tributary (locally known as Martin Creek) watershed, at 875 and 1041 Patricks Point Road, approximately 1 mile North of the town of Trinidad, County of Humboldt, State of California. The project is located in Southeast ¼ of Section 14, T8N, R1W, Humboldt Base and Meridian; in the Trinidad Range U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Numbers 515-241-014 and 515-241-002; Points of Diversion (PODs) 1 and 2 latitude 41.0754 and longitude -124.1430 and POD 3 latitude 41.0762 and longitude -124.1402.
