



Exhibit A2 EI Dorado AN (023-681-005) Plan Area #111 - Tahoe Island

Exhibit A3 El Dorado AN (025-353-012) Plan Area #107 - Black Bart




Exhibit A4 El Dorado AN (025-403-005) Plan Area #94 - Glenwood




Exhibit A5 El Dorado AN (027-142-014) Plan Area #92 - Pioneer Ski Run




Exhibit A6 El Dorado AN (032-313-028) Plan Area #113 - Industrial Tract




Exhibit A7 El Dorado AN (080-010-019) Plan Area #100 - Truckee Marsh




Exhibit A8 Placer AN (093-020-014) Plan Area #6 - Fish Hatchery




Exhibit A9 Placer AN (097-091-002) Plan Area #160 - Homewood Residential
