Recirculation of the Draft EIR

The original DEIR was circulated for public review and comment for a period of 45 days (March 6 - April 20, 2020). During the review period, public agencies and private parties provided comments on the original DEIR. The City has reviewed those comments and has identified potential issues of environmental concern that could benefit from modification and further discussion within a Recirculated Draft EIR (RDEIR). Additionally, the City recognizes that the recent COVID-19 pandemic has restricted public access to City facilities, as well as information available through the City, including but not limited to information presented in the original DEIR. Project Description: The proposed Project proposes construction of an auto dealership and supporting auto service uses totaling approximately 8,526 square feet within an approximately 4.76-acre Project site.
