Santa Ana	within the northwestern and central portions of Orange County. Project components are located at the sites of existing Sanitation District facilities, and work would primarily be limited to existing Sanitation District
Seal Beach	easements. Some construction activity and staging would occur outside Sanitation District easements, in the land use jurisdiction of the various municipalities listed in the PEIR and on unincorporated land within
