A Tentative Subdivision Map to divide an approximately 49.4-acre property into 47, 1-acre+ size lots. The project is proposed as a phased map. Phase I - 17 lots, Phase II - 19 lots and Phase III - 11 lots. Access will be via internal cul-de-sacs, served off Durham-Dayton Highway. The project's internal roads will be offered for dedication to the County and will be maintained as part of a Permanent Road Division (PRD). Future residential uses would be served by individual septic systems and community water (Durham Irrigation District).
