## Description of Nature, Purpose, and Beneficiaries of Project:

The project proposes to cultivate cannabis for commercial purposes on a parcel with the land use designation Specific Plan. Cultivation will occur in 21,858 square foot indoor facility with 18,067 square feet of warehouse space for cannabis cultivation, and an additional 3,791 square feet will be provided for general office use. Total flowering canopy area will not exceed 10,000 square feet. Plants will be grown within the indoor cultivation facility in individual light-sealed climatecontrolled rooms including, vegetative, drying, processing/trimming, and storage/vault rooms. Cannabis will be processed onsite and stored on the premise until a licensed cannabis distributor purchases the product and transports it.
