Project Title and File No.: Monte Vista Water District Plant 30 Wellhead Treatment Project

- **Project Location:** The proposed project is located at the 5616 San Bernardino Avenue, Montclair, CA 91763. The project will be located at the existing Monte Vista Water District Well 30 site, which is located in San Bernardino County. The project site is located within Section 23, Township 1 South, Range 8 West of the USGS 7.5 Minute Ontario topographical quadrangle. The GPS coordinates of the proposed project 34.077348°, -117.682896°.
- **Project Description:** Monte Vista Water District (MVWD or District) proposes to install a wellhead treatment facility that would provide groundwater treatment for Wells 30, 32, and 33. The proposed project would develop a Wellhead Treatment Plant within the existing Well 30 site to treat water delivered from MVWD Wells 30 and 32, and from Well 33, which is co-owned by both MVWD and the City of Chino. Phase 1 of the project will provide the capacity to treat up to 4,000 gallons per minute (GPM) and Phase 2 will facilitate the treatment of up to 6,000 GPM.

## Project Sponsor(s): Monte Vista Water District

This is to advise that the Monte Vista Water District, acting as the lead agency, has prepared an Initial Study to determine if the project may have a significant effect on the environment and is proposing to adopt a Mitigated Negative Declaration based on the following finding:

- The Initial Study shows that there is no substantial evidence that the project may have a significant effect on the environment.
- The Initial Study identified potentially significant effects but:
  - Revisions in the project plans or proposal made or agreed to by the applicant before this proposed Negative Declaration was released for public review would avoid the effects or mitigate the effects to a point where clearly no significant effects would occur; and,
  - (2) There is no substantial evidence before the agency that the project as revised may have a significant effect on the environment.
