Notice of Determination – Project Description

Parkwood CMD 19A&B Water System Improvements

The Parkwood CMD (County Maintenance District) 19 A&B Parkwood Water System (Proposed Project) proposes to construct and operate one municipal production well to supplement existing supplies in the northern portion of its service area, within Madera County. The project site consists of one existing offline well and its associated features.

This project would involve construction of above grade and below grade infrastructure improvements designed to bring online a new production well to replace an existing, offline well on the same parcel. The final product will be a groundwater well capable of producing approximately 1,000 gallons per minute (gpm) to meet all drinking water quality requirements. The design includes a 5-foot square concrete well pedestal, sole plate, base plate, discharge head, pump, motor, 360 feet of column pipe, and extension of the 3-inch gravel fill tube, and 2-inch sounding tubes. Although the well itself will have limited energy consumption, an emergency generator for the facility will be provided. This generator will be diesel powered and located at the northeast extent of the project area immediately adjacent to existing facilities

Additionally, new pipeline improvements would be constructed in needed areas identified by a 2016 infrastructure study, including two interties with the City of Madera. Approximately 500 new water meters will also be installed on the existing service connections.
