**PROJECT DESCRIPTION:** The SVWC proposes to demolish two 175,000 gallon partially buried rubber bladder reservoirs and construct two new partially buried concrete tanks (each 81,600 gallons) in the same footprint with minimal excavation. The reservoirs to be demolished are deteriorating in condition and badly in need of replacement. The existing rubber bladder reservoirs will be removed and disposed of as nonhazardous waste at the local landfill. The project will remediate a potential drinking water health threat to residents.

PUBLIC AGENCY APPROVING PROJECT AND CARRYING OUT PROJECT: This is to advise that the State Water Resources Control Board (State Water Board) has determined that the Project is exempt from the California Environmental Quality Act and will issue a drinking water supply permit for the operation of the above described Project.
