The California Department of Transportation (Caltrans), using State-only funds, is proposing a project that would create a valley gutter to route excess stormwater and sediment away from the State-owned sandhouse structure towards a single treatment BMP (traction sand trap). Construction would involve removal of existing pavement (grinding), minor grading, construction of new structural sections, construction of a valley gutter, and installation of a traction sand trap. Ground disturbance is expected to reach a max depth of three feet to dig a trench for the valley gutter and traction sand trap. Continued on page 2.
