Project Decription (Proposed actions, location, and/or consequences).

The proposed Project consists of the construction and operation of a 378-acre, approximately 70 mega-watt (MW) ac photovoltaic (PV) energy generation facility, battery energy storage system and associated infrastructure (e.g., access roads, perimeter fencing, weather station, etc.) on the site described above. The proposed Project would transmit the power generated directly to Southern California Edison's (SCE) 66kV Poplar-Terra Bella line. The power would then be sold to California investor-owned utilities, municipalities, or other purchasers. The Project proponent may eventually choose to decommission and remove all or none of the systems from the site. If the site is decommissioned, it would be properly reclaimed as an agricultural use or converted to another use consistent with the applicable land use regulations in effect at that time. If the site is not decommissioned, it is assumed that it will continue in use as a solar facility which will likely require processing for approval under subsequent CEQA review and SUP document.

The following is a summary of the potential impacts and mitigation proposed to reduce potentially significant impacts:

Air Quality: Engine standards for off-road equipment;

Biological Resources: pre-construction survey, worker environmental awareness program, general, general measures for the avoidance and protection of biological resources, nesting bird and raptor survey, avoid disturbance, bird collision reduction strategy, USFWS and CDFW coordination;

Cultural Resources: cease construction related activities within 50 feet of the find, contacting relevant parties, Hazards; and Hazardous Materials: HAZ-1 (Phase II Environmental Site Assessment), HAZ-2 (Suspected Asbestoscontaining Materials);

Noise: Construction noise reduction measures;

Tribal Cultural Resources: halt work and have qualified archaeologist make an assessment;
