Project Title: Streambed Alteration Agreement No. 1600-2019-0168-R2 "Plan 6" Timber Harvesting Plan 2-18-043-PLU, Soper Wheeler Company

The projects are located in Sly Creek, Lost Creek, and un-named tributaries to Lost and Valley creeks, in Plumas County, State of California. The projects are located on the American House, Strawberry Valley, and LaPorte U.S. Geological Survey (USGS) map, Township 21N, Range 8E, Sections 13, 24, 27, and 35; Township 24N, Range 8E, Section 24; Mount Diablo base and meridian (Exhibit A).

The project is limited to water drafting from four locations (A, B, C, and D); replacing a bridge (LCM16); and replacing two culverts (LC3 and LC5). Further information can be found in the THP 2-18-043-PLU.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):
