**Project Description:** The proposed Belmont Village Senior Care Facility consists of approximately 177 units (183 beds) of fully-licensed residential care facility for the elderly (RCFE), providing a mix of independent living, assisted living and secured memory care. The proposed project is a six-story, approximately 180,000 square foot building, on a 2.23-acre parcel including shared parking with the BR-1 office complex to the south, associated landscaping, lighting, and other amenities.

The CityWalk Master Plan analyzed buildout potential for up to 4,500 dwelling units, a 169-key hotel, 166,000 square feet of commercial uses, three new parking structures, and publicly accessible, privately owned and maintained park and public spaces. The Belmont Village project site is one of three parcels that comprise the BR-1A neighborhood within the CityWalk Master Plan. The BR-1A neighborhood is currently approved for up to 652 multifamily residential units for all three parcels, plus an approximately 1-acre park site. The proposed project will replace a portion of the housing units already anticipated by the CityWalk Master Plan and analyzed by the CityWalk Master Plan Environmental Impact Report (SCH# 2019090586)




