PROJECT TITLE: Jamison Mine Barn and Worker's Cabin Rehabilitation

LOCATION: Plumas-Eureka State Park

COUNTY: Plumas

DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT: Rehabilitate the Jamison Mine Barn west wall, adjacent lean-to and Worker's Cabin's south wall at Plumas-Eureka State Park to preserve this cultural resource for interpretation. Work will:

At the Jamison Mine Barn west wall and adjacent lean-to:

- 1. Install temporary posts, bracing, and ledger boards;
- 2. Replace all deteriorated/compromised sill plates with rough-sawn 6"x6" timbers;
- 3. Sister in new rough-sawn 2"x 6" studs to the existing deteriorated wall studs;
- 4. Replace all deteriorated siding on the west facade of the lean-to with in-kind materials that match the existing profile;
- 5. Reinforce the northeast corner where the lean-to meets the main barn; and
- 6. Scrape, sand, and prime the west wall of the lean-to.

At the Jamison Mine Southern Miner's Cabin

- 1. Fasten an 8' long 4"x4" timber horizontally to the exterior of the south wall;
- 2. Install an 8' long 4"x4" timber in the interior northeast corner of the cabin;
- 3. Install a ¼", or larger, cable and turn-buckle system that attaches to the center of each of the 8"x4"x4" timbers to straighten the partition wall between the south and east rooms; and
- 4. Install two (2) 4"x4" braces, one (1) 6'x2"x8" (horizontally) and a minimum of three 18" long concrete stakes a depth of 12" into the exterior grade on the exterior of the cabin to resist the outward thrust of the walls.
