PROJECT TITLE: Calaveras Big Trees Campsite Camp Host

DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT: Install a new camp host site near Cabins 1-4 in Calaveras Big Tree State Park to house a motor home for a camp host who will be responsible for conducting campground checks, collecting fees, firewood sales, answering questions from the public, performing light maintenance duties, and assisting ranger staff as needed. This project is an amendment to Cabin Expansion & Campsite Relocation Project (SCH: 2019099058). Work will:

- Excavate a 300' L x 18" W x 30" D trench, and install approximately 300' of 1.5" PVC Sch 80 pipe to establish a waterline that will be tied into existing waterlines;
- Place electrical conduit in the same trench as the waterline and connect into an existing conduit line in a pre-existing electrical box that will service future cabins;
- Excavate a 600' L x 18" W x 30" D trench and install 4" ABS to connect the new camp host site to the future cabins;
- Install a 60' L x 20' W x 5" D pad of gravel on a flattened area for camp host site along with an approximately 3' x 3' pad for a 100-gal upright propane tank, and;
- Install an additional 120' L x 12' W of roadway to create a through loop from the cabin parking lot to Cbtsp Fire Rd.
