This project proposes to enhance worker safety by improving pavement access, reducing recurrent maintenance activities and relocating roadside facilities to safe work locations on Interstate 5 from 0.2 mile north of the Anaheim Blvd. overcrossing to the Santa Ana Street undercrossing in the city of Anaheim. Project activities include installing concrete grid units and rock blanket, slope paving, roadside clearing, relocation/replacement of irrigation facilities and replacement planting. The total disturbed soil area (DSA) is anticipated to be less than one acre. All work will take place within the State right-of-way. The project will be funded with State and federal sources.
