Description or Nature, Purpose, and Beneficiaries of Project:

The project entails replacement of two existing concrete dock structures with two new wooden dock structures in order to maintain safe structures for docking vessels and loading passengers. The two dock structures encompass a combined area of approximately 0.04 acre (1,657 square feet) along 170 linear feet of affected shoreline. The new docks will be essentially the same size and shape as the existing docks; therefore, there will be no increase in the overwater shade coverage. The existing guide piles will be left in place for use with the new dock system.
