Subject: Addendum to Substitute Environmental Documents for a Basin Plan Amendment for Total Maximum Daily Loads for Dissolved Copper, Lead, and Zinc in Chollas Creek

In accordance with the California Environmental Quality Act (CEQA), the California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) has prepared a draft addendum to a Substitute Environmental Document (SED) for its proposed amendment to the *Water Quality Control Plan for the San Diego Basin (9)* (Basin Plan). The draft addendum addresses potential environmental effects of changes to the project; those effects that pertain to establishment of site-specific water quality objectives (WQOs) for dissolved copper and zinc; and those that pertain to establishment of site-specific water quality objectives (WQOs) for dissolved copper and zinc. The draft addendum supports a conclusion that the proposed project will not have a significant effect on the environment.

The draft addendum consists of a discussion in the technical report (section VII.D), a standard CEQA checklist, and a response to comments concerning potential downstream impacts. Pursuant to the State CEQA Guidelines, the San Diego Water Board has made these documents available for review online:

Prior to adopting the draft addendum, the expertise of your agency and other appropriate public agencies is needed to identify, evaluate, and offer mitigation measures for any environmental effect that may not have been adequately addressed.

The San Diego Water Board opened its public comment period on the proposed Basin Plan amendment on September 29, 2016. Oral comments will also be received during the public hearing on December 14, 2016. The time and location of the San Diego Water Board public hearing are provided below:
