ENDNOTES

Subsequent to the original total maximum daily load (TMDL) California Environmental Quality Act (CEQA) analysis, State legislation was passed that requires additional considerations; greenhouse gases, driven by Assembly Bill (AB 32), and tribal cultural resources, driven by AB 52. Therefore, this addendum also evaluates the generation of greenhouse gas emissions and impacts to tribal cultural resources.

Greenhouse Gases

There will be reduced potential environmental impacts resulting from the construction of fewer structural BMPs as a result of applying the site-specific water quality objectives (WQOs), including reduced energy use and greenhouse gas emissions, which will support reduction goals for greenhouse gases outlined in AB32.

Tribal Cultural Resources

Applying site-specific WQOs is not expected to cause a substantial adverse change in the significance of a tribal cultural resource as defined in Section 21074 of the Public Resources Code. Reasonably foreseeable management practices are not expected to result in a substantial adverse change in the significance of a historical or archaeological resource, directly or indirectly destroy a unique paleontological resource or site or unique geologic feature, disturb any human remains, or cause a substantial adverse change in tribal cultural resources because most management practices will be implemented in previously disturbed agricultural lands.

Additionally, California law protects Native American burials, skeletal remains, and associated grave goods regardless of the antiquity. Reasonably foreseeable structural controls may involve the disturbance of the near surface soil and not expected to require significant excavations or earth moving activities that may impact Native American cultural resources. Should human remains be discovered during excavation or earth moving activities, the impacts will be less than significant because California law protects Native American burials, skeletal remains, and associated grave goods regardless of the antiquity and provides for the sensitive treatment and disposition of those remains (Health & Safety Code, section 7050.5; Public Resource Code, section 5097.9 et seq).

Adoption of the Basin Plan amendment is not expected to result in an increased generation of greenhouse gas emission or impacts to the tribal cultural resources described above.
