

NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

Lead Agency: City of Cupertino
Project Title: Cupertino Parks and Recreation System Master Plan
Project Location: City of Cupertino

The City of Cupertino (City) has prepared an Initial Study / Mitigated Negative Declaration (IS/MND) for the Cupertino Parks and Recreation System Master Plan. It concludes that the proposed project would not have a significant effect on the environment because design features, best management practices, and mitigation measures incorporated into the project will avoid potentially significant impacts. The City is the Lead Agency and proponent for the project.

Project Description: The City intends to adopt and implement the City of Cupertino Parks and Recreation System Master Plan (Master Plan) which identifies opportunities for park improvements and development and is needed to provide overall guidance for long-term decision making.

The Master Plan is intended to ensure that the City the park and recreation system meets the needs of the Cupertino community, and to guide the City in allocating resources for future development, renovation, and management of City parks and recreation facilities through the year 2040. The key components of the Master Plan include vision and goals, systemwide objectives and actions, opportunities for enhancements, and associated implementation actions. The Master Plan is focused on city owned or managed developed parks and recreation facilities in Cupertino, and does not cover natural open spaces, or other non-City owned assets such as county and regional parks.

Public Review Period: A 30-day public review period for the IS/MND will commence October 23, 2019 and continue through November 22, 2019. Interested individuals and public agencies may submit written comments on the document, which must be received by the City no later than 5:00 PM on November 22, 2019. Please send your comments to:


