**PROJECT DESCRIPTION:** The State Water Resources Control Board (State Water Board) is the Lead Agency for the Project. The State Water Board's Drinking Water State Revolving Fund (SRF) Program is financing the Project. The Project includes installation of a Calgon Granulated Adsorption Carbon Treatment System, a 98,000-gallon welded steel water tanks, a back-up generator, three vertical turbine booster pumps, a replacement pump for well #5, a new building located within the footprint of the existing watermain, abandonment of well#2, and demolition and removal of the existing hydropneumatic tank building.

**PUBLIC AGENCY APPROVING PROJECT AND CARRYING OUT PROJECT:** The State Water Board approved SRF financing for the Project described above on October 31, 2019 and determined that the Project is exempt from the California Environmental Quality Act. The Applicant will be carrying out the Project.

**CATEGORICAL EXEMPTION STATUS:****Class 3: New Construction or Conversion of Small Structures**


