PROJECT TITLE: Residence 2 and 31 Shingle Roof Replacement

LOCATION: Columbia State Historic Park

COUNTY: Tuolumne

DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT: Replace the roofs on Residences #2 and #31 in Columbia State Historic Park to ensure continued use of the residences as either staff housing or as public rentals. At each residence, reroof project work will:

- Remove rotted or compromised materials and, where possible, record and preserve historic materials in place;
- As needed, install new skip sheathing, topped by a layer of plywood;
- Install a layer of ice and water shield over the plywood and install metal flashing at the valleys, ridges, and around existing vents and chimneys;
- Install a layer of Cedar Breather and top with wooden fore-retardant treated #1 cedar shingle, cut and laid-to-weather "in-kind" to match look of an historic roof;
- Repair or replace metal rain gutters and downspouts; and
- After one (1) year, spray the roof shingles with Armstrong-Clark water repellent to extend their life.

All work will be in conformance with the Secretary of the Interior Guidelines on Treatment of Historic Properties standards.

REASONS WHY PROJECT IS EXEMPT: Project consists of the repair, maintenance and minor alteration of existing public or private structures involving negligible or no expansion of use beyond current levels; replacement or reconstruction of existing structures and facilities where the new structure will be located on the same site and the structure replaced and will have substantially the same purpose and capacity as the structure replaced and is included as "Reroofing" in the Department of Parks and Recreation's list of exempt activities in accordance with CCR § 15300.4.
