**Project Title:** Sour Boards Timber Harvest Plan No. 4-18-00128/TUO (Streambed Alteration Agreement No. 1600-2018-0266-R4)

**Project Location:** The Project locations occur in Township 5 N, Range 16 E, Sections 08, 16, 17, and 19; Township 6 N, Range 16 E, Section 35; in the Boards Crossing and Dorrington USGS 7.5 minute quadrangles, between the North Fork Stanislaus River and Beaver Creek in Tuolumne County.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number 1600-2018-0266-R4, pursuant to section 1611 of the Fish and Game Code to the project Applicant, Sierra Pacific Industries. Project activities include installation of permanent and temporary and permanent crossings, waterhole excavation, and operations, and other activities at water drafting sites, related to the Sour Boards Timber Harvest Plan in Tuolumne County, No. 4-18-00128/TUO.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on 11/21/19 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the Timber Harvest Plan prepared by the Lead Agency for this project pursuant to Z'berg-Nejedly Forest Practice Act and the California Forest Practice Rules, a CEQA-equivalent California Certified Regulatory Program.
3. Mitigation measures were made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was adopted by CDFW for this project.
5. A statement of overriding considerations was not adopted by CDFW for this project.
6. Findings were made by CDFW pursuant to the Provisions of CEQA.
