This letter, prepared by Applied EarthWorks, Inc. (Æ) on behalf of KB Home Southern California/Coastal, summarizes the results of the cultural resource constraints analysis for approximately 44 acres of land within Assessor's Parcel Number 3072-251-27. The developer proposes to construct a 174-lot residential housing tract complex located on the southeast corner of Sycamore Street and Amethyst Road in the City of Victorville, San Bernardino County, California.

Cultural Resource Literature and Records Search Results

A cultural resource literature and records search was conducted at the South Central Coastal Information Center (SCCIC), housed at the California State University, Fullerton, on August 15, 2017. The objective of the records search was to determine whether any prehistoric or historic-period cultural resources were recorded previously within, or within a one-mile radius of, the property. The results of this search indicate that no fewer than 27 cultural resource investigations were completed within a one-mile radius between 1976 and 2016; two of these studies specifically involved a portion of the property (Table 1). Less than 20 percent of the property has been previously surveyed as a result of this study.

As a result of these and other similar studies, 13 cultural resources have been documented within a one-mile radius of the property (Table 2). These include eight historical archaeological resources (five refuse scatters, two can scatters, and an abandoned single-family residence), two built-environment resources (both transmission lines), and three isolated artifacts (a prehistoric hammerstone, historical amethyst glass fragments and a metal can, and a single amethyst glass fragment). None of these resources are located within, or in the immediate vicinity of, the property.

Historical maps consulted during the cultural resource literature and records search include the 1902 Hesperia 1:62,500 USGS Map, the 1942 Hesperia 1:62,500 US Army Corps of Engineers War Department map, the 1953 and 1966 San Bernardino 1:250,000 USGS Map, and the 1956 and 1968 Hesperia 1:24,000 USGS Maps. None of these historical maps show any buildings, structures, or other historical features within or immediately adjacent to the subject property.

Sacred Lands File Search Results

Æ requested a Sacred Lands File (SLF) search of the property from the Native American Heritage Commission (NAHC) located in Sacramento, California on August 14, 2017. The NAHC responded by letter on August 23, 2017 stating that the SLF search was completed with negative results.

Management Recommendations

The records search has indicated that only a small portion of the property has been subjected to intensive archaeological survey. As such, it is recommended that a complete Phase I cultural resource study of the property, including a pedestrian survey, be undertaken to assess the overall sensitivity of the property.
