Project Description:	To allow for the recordation and development of a 168-lot single-family residential subdivision (Tentative Tract Map 20274) with 7,200 sq. ft. minimum size lots, on an approximately 44-acre building site that is vacant and undeveloped with an approximate density of 3.8 units per acre.	
Project Location:	East of and abutting Amethyst Road and north of Eucalyptus Street; APN:3072-251-34; Within the City of Victorville, County of San Bernardino, State of California, San Bernardino Meridian, Section 1, Township 4N, Range 5W.
