Project Title: Vaca Valley Hyatt Hotel Project (Lake or Streambed Alteration Agreement No. EPIMS-SOL-13063-R3)

Project Location: Horse Creek in the County of Solano. The project area is bounded by Vaca Valley Parkway to the north, East Monte Vista Avenue to the east, Piper Drive to the south, and Cessna Drive to the west at approximately Latitude 38.3944°, Longitude -121.95402°.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed a Major Amendment to Lake and Streambed Alteration Agreement number EPIMS-SOL-13063-R3, pursuant to section 1602 of the Fish and Game Code to the project Applicant, J&P Hospitality, as represented by Jaspreet Sidhu.

The project, as amended, will install an approximately 55-foot long, 10-foot wide, 5-foot high pre-cast concrete box culvert in Horse Creek. Approximately 1,306 square feet of Horse Creek will be enhanced on-site by removing existing concrete rubble and planting native species. The major amendment allows this work to occur within 0.25 miles of an active Swainson's hawk nest provided strict monitoring protocols are enforced and Swainson's hawks remain undisturbed by the project activities.
