Mr. Nevill,

Thank you for your availability to discuss the OCWD - SA-5 Replacement Project. After reviewing the project's proposed ground disturbance activities and the project's location, in relation to its distance from known indicators to our resources, we have concluded that your project has a low potential to impact Tribal Cultural Resources (TCR). Therefore, additional mitigation for monitoring for TCR's is not necessary for this project. However, there is always a chance for discoveries, so if something is inadvertently found please include a statement in the conditions of approval and/or mitigation measures to have the project staff contact our Tribal Government if any inadvertent finds are discovered. We thank you for your time and effort in this matter and this correspondence will officially conclude AB52 consultation for this project.
