NOTICE OF EXEMPTION

PROJECT TITLE: Tuolumne Road Chip Seal and Repairs Project (#1722)

PROJECT PROPONENT: Tuolumne County Department of Public Works

LOCATION: The project boundaries are on Tuolumne Road, from Mono Way to Tuolumne Road North/Cherry Valley Boulevard, a distance of 6.97± miles. Portions of Sections 1,4, 5,10 and 11 Township 1 North, Range 15 East; and Sections 5 and 6 Township 1 North, Range 16 East, Mount Diablo Base and Meridian. Supervisorial Districts 3 and 4.

COUNTY: Tuolumne

PROJECT DESCRIPTION: The project consists of the road surface treatment (chip seal) of Tuolumne Road. The chip seal will be applied to the existing road width. There may be base spot repairs (aka "dig-outs") performed within the existing pavement envelope, prior to the application of the chip seal, to a depth no greater than three feet below the existing road surface. No widening of the road or work on the non-paved sections of the roadway are anticipated. Following the chip seal, the road lanes will be striped with waterborne retroreflective paint. The project is to maintain an existing County road facility.
