NOTICE OF DETERMINATION
(Public Resources Code section 21108)

Title: Pup's Ferry (Campbell Creek) and Bass Canyon (North Fork Salt Creek) Timber Harvest Plans (THPs)

Proponent: Sierra Pacific Industries

Location: Northeast of Lakehead, Shasta County.

Description: THP No. 2-18-017-SHA (Pup's Ferry) and THP No. 2-18-026-SHA (Bass Canyon) would require construction and use of three segments of low-grade forest roads on State-owned school land for the purpose of accessing Sierra Pacific property and removing logs from two timber harvest areas on Sierra Pacific property. The State Lands Commission action is an approval of a 20-year General Lease – Right-of-Way Use through December 5, 2039.

This is to advise that the California State Lands Commission, as Lead Agency Responsible Agency, approved the above described project on December 6, 2019, and made the following determinations regarding the project.

- 1) The project will will not have a significant effect on the environment.
- 2) A substitute document prepared under a certified state regulatory program was prepared for this project pursuant to the provisions of CEQA (Cal. Code Regs., tit. 14, § 15251, subd. (a)).
- 3) Mitigation measures were were not made a condition of the approval of the project.
- 4) A mitigation reporting or monitoring plan was or was not adopted for this project.
- 5) A Statement of Overriding Considerations was was not adopted for the project.
- 6) Findings were were not made pursuant to the provisions of CEQA.

Environmental analysis documents Timber Harvest Plan No. 2-18-017-SHA and 2-18-026-SHA were adopted on May 23, 2018, and July 26, 2019, respectively, for this project by the California Department of Forestry and Fire Protection (CAL FIRE) under its certified program (Cal. Code Regs., tit. 14, § 15251, subd. (a)). The State Lands Commission has reviewed and considered the information therein, concurred with the CDF's determination, and used the CAL FIRE document as a substitute Negative Declaration equivalent under CEQA.
