The key consideration for projects in this class is whether the project involves negligible or no expansion of an existing use. The Renovation for Efficiency and Science Modernization project would result in no expansion to floor area of existing buildings, and would replace existing exterior access walkways with accessible and heated walkways to more safely serve faculty, staff, students and visitors. Therefore, the project qualifies for this exemption.

Notice of Exemption for the Remodel for Efficiency project as presented.

### **Public Content**

The California Environmental Quality Act (CEQA) is a statute that requires state and local agencies to identify the significant environmental impacts of their actions and to avoid or mitigate those impacts, if feasible. A public agency must comply with CEQA when it undertakes an activity defined by CEQA as a "project." A project is an activity which must receive some discretionary approval (meaning that the agency has the authority to deny the requested permit or approval) from a government agency which may cause either a direct physical change in the environment or a reasonably foreseeable indirect change in the environment.

Most proposals for physical development in California are subject to the provisions of CEQA, as are many governmental decisions which do not immediately result in physical development (such as adoption of a general or community plan). Every development project which requires a discretionary governmental approval will require at least some environmental review pursuant to CEQA, *unless an exemption applies*.

CEQA exemption categories are defined within Title 14 of the California Code of Regulations, Chapter 3, Article 19 "Categorical Exemptions". Article 19 includes a list of classes of projects which have been determined not to have a significant effect on the environment and which shall, therefore, be exempt from the requirement for the preparation of environmental documents.

The Remodel for Efficiency (RFE) project qualifies for CEQA exemption under Section 15301 which allows for the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing

at the time of the lead agency's determination. The key consideration for projects in this class is whether the project involves negligible or no expansion of an existing use. The RFE project would result in no expansion to floor area of existing buildings, and would replace existing exterior access walkways with accessible and heated walkways to more safely serve faculty, students and visitors. Therefore, the project qualifies for this exemption.
