Request:

The City is proposing a Specific Plan to create a policy framework to guide future

commercial and residential development within the Plan area. The Specific Plan

assumes buildout of one of two scenarios. The first would include approximately 12,000

net new residential units and 310,000 net new square feet of non-residential uses,

including retail and education facilities. The second scenario would be the same as the first but would substitute office for high-density residential along the west edge of the Plan Area, amounting to an approximate total of 10,300 net new residential units, 785,000 net new square feet of office, and 310,000 net new square feet of other non-

residential uses.

As authorized by the City of Santa Clara as a Lead Agency, the City is seeking the views of responsible agencies and the public as to the scope and content of the environmental information that should be considered for inclusion in the Program Environmental Impact Report (EIR) for the proposed project. The project description, location, and potential environmental effects are contained in the materials provided in the form of a Notice of Preparation (NOP). The NOP is available from the Planning Division Office at the address below, and is available on line at the City's website (www.santaclaraca.gov/CEQA).
