AVILA BEACH DRIVE AT STATE ROUTE 101 INTERCHANGE IMPROVEMENTS PROJECT DESCRIPTION

Project Description

The County of San Luis Obispo (County) Department of Public Works proposes to construct interchange improvements at the Avila Beach Drive at State Route (SR) 101 interchange.

The proposed project is a County and California Department of Transportation (Caltrans) capital improvement project. The purpose of the project is to improve the Avila Beach Drive at SR 101 Interchange northbound and southbound ramp intersections to address traffic operational and safety deficiencies and improve multimodal access. The project is located in Supervisorial District 3.

The existing interchange includes the northbound SR 101 exit ramp and Monte Road on the east side of SR 101, and the southbound SR 101 off- and on-ramps, Shell Beach Road, and Avila Beach Drive on the west side of SR 101. Traffic patterns are challenging for motorists and bicyclists. The proposed improvements consist of three main components:

1. A roundabout at the southbound ramp intersection.
2. Modifications to the northbound off-ramp.
3. A park-and-ride lot and Regional Transit Authority bus stop at the southwest corner of Avila Beach Drive and Shell Beach Road.

The improvements will include shared-use paths for pedestrian and bicycle crossing through the intersection. The project design includes appropriate retaining walls, stormwater features, and maintenance of existing utilities.

Construction access will be accomplished by working from the existing road surfaces and rights-of-way. Construction materials and equipment may be stored at the existing maintenance pullout area along the northbound off-ramp at the southeast end of the project and in the future park-and-ride area.

Construction is expected to take approximately 2.5 years to complete with most activities occurring in the first two years.
