

Notice of Intent to Adopt a Proposed Mitigated Negative Declaration (Study Results Available)

U.S. 101 San Jose Creek Bridge Replacement



PUBLIC COMMENT PERIOD

Comments will be accepted from Monday April 13, 2020 and end Wednesday May 27, 2020

The project will not offer the opportunity for a public hearing

· Due to COVID-19 and to avoid public gatherings. No State/Federal legal requirements to offer or hold a public hearing.

WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans) proposes to replace the San Jose Creek Bridge in Santa Barbara County on U.S. 101 at post mile 21.6. The project is within the City of Goleta. The concrete portion of the bridge contains reactive aggregate, which may weaken the bridge's structural integrity. Replacing the bridge is the best solution to address the reactive aggregate and to ensure the function and reliability of the highway. The new bridge will be designed as a single-span structure that will meet current bridge standards. The project will also upgrade railing, improve habitat conditions, and improve hydrologic conditions.

WHY THIS PUBLIC NOTICE?

Caltrans has studied the effects this project may have on the environment. Our studies show the project will not significantly affect the quality of the environment. More information regarding this finding is included in Caltrans' Initial Study with Proposed Mitigated Negative Declaration and Environmental Assessment. The draft environmental document was previously distributed to the public; public comments were accepted from December 13, 2019 to January 17, 2019. Based on the public comments received, Caltrans has revised the draft environmental document and is recirculating it to the public. The results of the study are also available for the public to review.
