CDFA Plant Health Division proposes to continue statewide monitoring, detection, and eradication activities in order to eradicate infestations of the hydrilla plant (*Hydrilla verticillata*). Hydrilla has the potential to be detected in any waterway in the State. Once introduced, hydrilla rapidly reproduces and depletes all of the dissolved oxygen in a waterbody, choking out all other vegetation and wildlife. Under the proposed project, CDFA would have the ability to rapidly respond and treat infestations in order to achieve eradication.
