Project Description:

The proposed project includes the installation of approximately 7,400 linear feet of 6-inch polyvinyl chloride (PVC) recycled water pipeline within the paved right-of-way of Manchester Avenue and El Camino Real.

Construction of the project is expected to begin in winter of 2020. The new pipeline would be constructed via standard cut and cover technique with the bottom of the trench extending 4 to 6 feet below grade and between 24 to 32 inches wide. Typical construction equipment employed would include a backhoe, flatbed supply trucks, pickup trucks, excavator, and dump trucks. Project construction activity could occur in one or two phases, dependent upon the prices received during bidding, with construction lasting approximately six months. Construction equipment would not be located at a single point for an extended period of time. Rather, multiple pieces of construction equipment would move along the alignment. Based on an average working distance of 350 feet per day, when the active work area is directly adjacent to a given receiver, construction activities throughout the day would be an average distance of 175 feet along an active portion of the alignment from any adjacent receiver. Project construction would occur between the hours of 9:00 a.m. and 3:00 p.m., Monday through Friday only (not on the weekend) and excluding federal holidays.

RESOLUTION OF THE BOARD OF DIRECTORS OF THE OLIVENHAIN MUNICIPAL WATER DISTRICT CERTIFYING THE ENVIRONMENTAL INITIAL STUDY AND FINAL MITIGATED NEGATIVE DECLARATION FOR THE PROPOSED MANCHESTER AVENUE RECYCLED WATER PROJECT

WHEREAS, pursuant to the California Environmental Quality Act, as amended (hereinafter referred to as "CEQA"), State of California Guidelines for Implementing CEQA, and the Olivenhain Municipal Water District Guidelines for implementing CEQA, the Olivenhain Municipal Water District's Board of Directors has caused to be prepared an Initial Study (hereinafter referred to as the "IS") and a draft and final Mitigated Negative Declaration (hereinafter referred to as the "MND") for the proposed Manchester Avenue Recycled Water project (Manchester RW); and

WHEREAS, the IS and the draft and final MND have been prepared per CEQA statutes and guidelines by RECON Environmental, Inc.;

WHEREAS, the Manchester RW Project will have less-than significant or no impacts in the following areas: Aesthetics, Agriculture and forestry reserves, Air quality, Geology/soils, Greenhouse gas emissions, Hydrology/water quality, Land use and planning, Mineral resources, Noise, Population and housing, Public services, Recreation, Transportation/traffic, and Utilities and service systems; and

WHEREAS, the Manchester RW Project may potentially have significant effects in the areas of: Biological resources, Cultural resources, Geology/soils, and Tribal cultural resources; however, each impact can be mitigated to avoid the impact or reduce it to a less significant level as described in the Mitigation Monitoring and Reporting Plan included in the Final MND; and

WHEREAS, on November 13, 2019, following the review of the IS and Draft MND, the Board of Directors released the IS and draft MND for public review and gave notice of a public review period running from December 1, 2019 to January 15, 2020 for the receipt of written comments from responsible agencies, interested agencies, and interested persons and set the time and place for a public hearing; and

WHEREAS, the IS, Draft MND, and Notice of Intent to adopt an MND and a Notice of Public Hearing were mailed to responsible and trustee agencies and to other potentially interested agencies; and

WHEREAS, a Notice of Intent to adopt an MND and Notice of Public Hearing was sent to all parties located within 1000 feet of the proposed project on December 18, 2019, published on the District's website, and published in the San Diego Union Tribune, a paper of general circulation, on December 27, 2019 and January 5, 2020; and WHEREAS, a Notice of Intent to adopt an MND was filed in the Office of the County Clerk January 8, 2020; and

WHEREAS a public hearing was held on January 15, 2020 at 5:30 p.m. No public comments were received at the meeting; and

WHEREAS, the District received comments from the Governor's office of Planning and Research and the California Department of Transportation; however, the comments are administrative in nature and no written comments regarding environmental impacts of the Manchester RW project were received; and

WHEREAS, after review of all written comments, preparation of responses to comments hereto, preparation of a Mitigation Monitoring and Reporting Program, and changes to the Draft MND, a Final MND is to be presented to the Board of Directors on Wednesday, March 18, 2020; and

WHEREAS, having heard, considered, and reviewed the documents and the information, and being fully advised regarding the environmental consequences of the proposed project, it is in the interest of the Olivenhain Municipal Water District and the people it serves to certify the Final MND as complete and adopt the mitigation measures contained within the Final MND.

NOW, THEREFORE, THE BOARD OF DIRECTORS OF THE OLIVENHAIN MUNICIPAL WATER DISTRICT DOES HEREBY FIND, DETERMINE, RESOLVE, AND ORDER AS FOLLOWS:

<u>Section 1.</u> The foregoing facts are found and determined to be true and correct.

Section 2. Pursuant to CEQA, State of California Guidelines for Implementing CEQA, and the Olivenhain Municipal Water District Guidelines for implementing CEQA, the Olivenhain Municipal Water District's Board of Directors certifies that the IS and Final MND, as described in Exhibit "A," has been completed in compliance with and satisfies all requirements of CEQA, and that the Board of Directors has independently reviewed and considered the IS and Final MND prior to approval of the Manchester Avenue Recycled Water Project.

Section 3. The Board of Directors of the Olivenhain Municipal Water District directs the District's management to file a Notice of Determination stating that the Board of Directors has approved the project and that following mitigation, the project will not have a significant environmental effect, and that a Final MND has been prepared pursuant to the provisions of CEQA.

<u>Section 4.</u> The Board of Directors finds and determines that all significant environmental effects of the project have been mitigated to a level of insignificance as a result of mitigation
