**A Director's Order was issued to repair damaged mechanical components on the Three Mile Slough Bridge (Bridge 24-121) on Route 160 in Sacramento County at postmile L7.0. The scope of work includes replacing the damaged wire rope with new. In addition, traffic control and COZEED will be required. This project is needed to avoid the failure or threat of failure to the transportation system and to prevent or mitigate the loss or impairment of life, health, property, and essential public services.**
