**Project Location (include county):** The Project is located at unnamed drainages tributary to Palm Canyon Wash about 0.5 miles northwest of the City of Ocotillo, in the County of Imperial, State of California; Latitude 32.74944<sup>o</sup> N, Longitude 116.01611<sup>o</sup> W. Section 26, Township 16 South, Range 9 East, U.S. Geological Survey (USGS) map Carrizo Mountain, San Bernardino Meridian.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number 1600-2019-0137-R6, pursuant to section 1602 of the Fish and Game Code to the project Applicant, the Emory Trust.

The Project is limited to the construction of 2,200 linear foot extension to an existing 54-foot-wide private airstrip including the creation of a proposed 6-foot-wide drainage swale along the south side of the extension. The 0.3-acre constructed swale would be the extension of the existing swale along the south side of the existing airstrip. The eastern 100 feet of the new swale would be deepened to 8 feet to form a runoff containment ditch.
