**PROJECT TITLE:** Residence #8 Deck Replacement

**LOCATION:** Columbia State Historic Park

**COUNTY:** Tuolumne

DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT: Repair and/or replace the deck at Residence #8 in Columbia State Historic Park to provide a safe outdoor space for park staff or resident. Work will:

- Remove and dispose of the failed components of the existing deck; •
- Install temporary bracing to stabilize the existing awning structure;
- Grade the ground to level and excavate to install fifteen (15) 12" x 12" x 12" precast concrete piers set 0 in concrete:
- Use pressure treated douglas fir lumber for installation of new girder and joist framing; 0
- At south and west sides of the existing cement foundation attach a new 2"x 6" pressure treated ledger;
- Attach 2"x 6" pressure treated douglas fir joists every 16"; .
- Replace decking planks with full dimension rough sawn 1"x12" ponderosa pine;
- Replace the 4"x4" posts supporting the porch roof structure;
- Reconstruct the collapsed railing with in kind materials;
- At front west side of the building, use 2"x12" pressure treated douglas fir and 1" x 12" rough sawn ponderosa pine to reconstruct the 4' wide staircase and rebuild the stair railings in kind; and
- Paint the stairs and railing with exterior white paint and stain the deck treads or surface with Armstrong rustic brown semi-transparent stain.
