The California Department of Transportation (Caltrans) proposes to reduce the erosion of the existing cut slope on Interstate 80 in Nevada County from postmile 28.3-28.7 The existing cut slope continually releases rocks and soil from erosion, which is creating a safety problem. The slope will be covered with erosion control material, and a concrete barrier will be installed along with edge of the shoulder. As well as, vegetation removal is expected.
