Description of Nature, Purpose, and Beneficiaries of Project: On December 6, 2019, DWR requested authorization from the State Water Resources Control Board (State Water Board) for a temporary variance from Condition No. 1 of the South State Water Project's (Project; Federal Energy Commission [FERC] Project No. 2426) water quality certification (certification) to temporarily increase the amount of water delivery from Pyramid Lake to United Water Conservation District (United) at Piru Lake, middle Piru Creek. Condition 1 of the Project's certification requires stream releases from Pyramid Lake match natural inflow, and has a limitation of 3,150 acre-feet. DWR requested to deliver an additional 5,837.5 acre-feet to United, for a total of 8,987.5 acre-feet. A variance to Condition 1 of the certification will allow for a one-time delivery total of 8,987.5 acre-feet of water from Pyramid Lake to Piru Lake by the end of February 2020. The release will mimic the natural hydrograph, include a gradual ramp up and ramp down of flows, and a peak flow similar to that of a typical storm event. The proposed increase of the Project's water delivery is to help replenish critically depleted groundwater conditions within United's service boundary.
