Project Location-Specific: The El Capitan Reservoir catchment, or Upper San Diego River Watershed, is in the eastern central portion of San Diego County, bounded by the communities of Ramona and Lakeside to the west, Julian and Santa Ysabel to the north, and Descanso and Alpine to the south. Invasive aquatic species removal will occur within the San Diego River stream system above El Capitan Reservoir on US Forest Service lands.

Project Location-City: Ramona

Project Location-County: San Diego

Description of Nature, Purpose and Beneficiaries of Project: The purpose of the project is to enhance and protect the El Capitan Reservoir through targeted removal of invasive species. Maintenance and stormproofing of Cedar Creek roads on US Forest Service lands will be performed, in addition to road drainage improvement with the intent of minimizing erosion and sediment transport/delivery to stream channels.
