


<p>The California Department of Transportation (Caltrans) proposes to extend the service life of State Route 76 from post miles R4.2 to R6.4, within San Diego County by constructing a 0.1-inch Micro-surfacing on the existing roadway. Additional work would include cold planning of the shoulders. All construction would occur within the State right-of-way. See attached Environmental Commitments Record for project conditions.</p>
