**Project Title:** Sonoma 1 Drainage System Restoration Project (Lake or Streambed Alteration Agreement No. EPIMS-SON-27455-R3.

Project Location (Sonoma): The Sonoma 1 Drainage System Restoration Project (Project) is located along State route (SR) 1 in Sonoma County, California from Post Mile (PM) 41.2 to PM 54.6 between 0.2 miles north of Miller Creek to 3.7 miles north of Black Point.
