PROJECT DESCRIPTION: (Briefly describe project including need, purpose, location, limits, right-of-way requirements, and activities involved in this box. <i>Use Continuation Sheet, if necessary.</i>) A Director's Order was issued to remove and replace failed Portland Cement Concrete (PCC) slabs on Interstate 5 and Highway 50 in Sacramento County from PM 0.0 to 24.64 and PM L0.50 to R5.75, respectively. The scope of work includes sawcutting, removing and replacing failed PCC slabs of varying sizes, striping and traffic control. In addition, COZEEP will be required. These repairs are needed to avoid the failure or threat of failure to the transportation system and to prevent or mitigate the loss or impairment of life, health, property, and essential public services. All staging would take place within the Caltrans right-of-way. All work is within the Caltrans right-of-way. No borrow or disposal is required. No need for consultation or coordination. No permits are required.
