Project Title: Streambed Alteration Agreement No. 1600-2020-0029-R2 (Brass Creek Timber Harvesting Plan 4-19-00139-ELD, Sierra Pacific Industries)

Project Location: The projects are located within the boundaries of a timber harvesting plan in El Dorado County, within CALWATER watersheds Brass Creek and Lower Pilot and their connecting tributaries; The project locations are found on the Tunnel Hill 7.5-minute U.S. Geological Survey (USGS) Quadrangle Map, Township 12N, Range 11E, Section 01 and Township 13N, Range 11E, Section 35; Mount Diablo Base and Meridian.
