Project Title: Streambed Alteration Agreement No. 1600-2020-0031-R2 (Uber Timber Harvesting Plan 4-19-00184-ELD, Sierra Pacific Industries)

Project Location: The project is located within the boundaries of a timber harvesting plan in El Dorado County, within CALWATER watershed North Sly Park Creek. The project location is found on the Old Iron Mountain 7.5-minute U.S. Geological Survey (USGS) Quadrangle Map Township 10N, Range 14E, and Section 21 Mount Diablo Base and Meridian.

Project: The project is limited to the construction of a temporary spittler crossing to be utilized by tractor equipment during timber harvest operations. The spittler crossing will be constructed by bundling cull logs and a 24-inch diameter by 20-foot long culvert pipe using chokers.
