Project Title: Union Mine Culvert Repair

Project Location – Specific: The Union Mine Culvert allows an unnamed seasonal creek to flow underneath Union Mine Road approximately 60 feet north of Canary Lane (Milepost 0.17) in unincorporated El Dorado County.

Project Location – City: Unincorporated

Project Location - County: El Dorado

Description of Project: On an unknown date, El Dorado County Department of Transportation (DOT) installed a 12-foot concrete box culvert under Union Mine Rd. The culvert was repaired (exact date unknown) by installing a metal pipe culvert 4' squished and 12' long into the existing box culvert. In 2015, DOT staff observed the metal pipe deteriorating and impacting the flow of the unnamed seasonal creek and causing shoulder and road failure.

The proposed repair project would build on the foundation of the original concrete box culvert by reinforcing the concrete box and adding an 8-foot extension including new wing walls, new footings, extension walls, abutment wing walls and lid. Culvert repairs will be done from the roadway above the ordinary high water mark. There will be no heavy equipment or construction materials used or placed below the ordinary high water mark. Repair work will occur while the creek is dry.
