Project Description:	To allow for the recordation and development of a 17-lot single-family residential subdivision (Tentative Tract Map 18940) with 7,200 sq. ft. minimum size lots, on an approximately 5-acre building site that is vacant, undeveloped, and previously disturbed with an approximate density of 3.4 units per acre.	
Project Location:	West of and abutting Second Avenue between Country Ranch Court and Silica Drive just north of the intersection of Silica Drive and Second Avenue; APN:3091-141-02; Within the City of Victorville, County of San Bernardino, State of California, San Bernardino Meridian, Section 33, Township 5N, Range 4W.
